This material offers easy processability into thin films with good balance of slip, mechanical and optical properties. It contains slip (580 ppm) and antiblock (1200 ppm) additives and antioxidant additives.

- Film for automated packaging

Recommended melt temperature range from 140 to 160°C. Processing conditions should be optimized for each production line.
